## 2011 LEGAL FEES

### GUARDIANSHIP AND PROBATE

Our legal fee for guardianship is \$275/hour for Partner (\$225/hour Associate). Guardianship legal fees usually around \$2,900 the first year and approximately \$1,000 each year thereafter. Probate legal fees may total between \$5,000 and \$7,000 (or more) per estate, exclusive of any estate tax return services, depending upon complexity of the estate.

### REVOCABLE LIVING TRUST(S)
